

**BOARD OF SELECTMEN**  
**JULY 11, 2018**  
**REGULAR SESSION**

Members Present: David Viera, Michelle Hines, Chris Zorra

Absent: Nelson Almeida, David Andrade

Town Administrator: Shawn E. Cadime

Mr. Viera, Clerk, opened the meeting at 7:02 p.m. followed by the Pledge of Allegiance and moment of silence.

He announced that, in accordance with M.G.L. Chapter 30A, Section 20(f), any person recording the meeting must notify the Chairman. The Board of Selectmen is recording via audio and video.

Mr. Viera announced that volunteers are needed on the Board of Registrars (1 Board of Selectmen appointment), Capital Improvement Committee (1 BOS), Charter Study Committee (up to 6 BOS), Conservation Commission (2 BOS), Cultural Council (2 BOS), Energy Committee (2 BOS), Historical Commission (3 BOS), Human Services Council (1 BOS), Parks & Recreation (1 BOS), Property Tax Work-Off Committee (3 BOS), Recycling Committee (up to 4 BOS).

**Consider the Conditional Offer of Employment to Dennis Pereira for the Position of Patrolman 3<sup>rd</sup> Class**

Capt. Frank John stated that the Department received numerous applications from academy-trained police officers who want to laterally transfer to Seekonk. There is currently one vacancy and another will be available in August.

Through Mr. Cadime, he requested the conditional offer of employment to Dennis Pereira to the position of Patrolman 3<sup>rd</sup> Class.

Mr. Cadime recommended as stated by Capt. John.

Ms. Hines commended her on her years of service in Seekonk. She is well prepared for her new position in Attleboro.

**BOARD OF SELECTMEN LIAISON REPORTS AND COMMENTS**

**Veterans Memorial Park Committee Liaison Report**

Mr. Viera advised that necessary corrections are being made on some of the bricks.

Ms. Hines reminded residents about the Second Annual Family Fun Day on Saturday, August 4, 2018 from 11 a.m. to 2 p.m. at the Hurley School. It is free. People are asked to bring canned goods for Doorways. The first 200 students in grades K-6 will receive a backpack filled with supplies. Backpacks are donated by The Salvation Army. Herb Chambers Honda donated supplies.

She talked about the Attleboro Dye Works on Maple Avenue. The site was vacated and abandoned by the owners many years ago and it suffered a fire several years ago. It is considered a Brownfields site.

An Attleboro Dye Works Committee was set up. This committee would like to hear from anybody who worked there or has knowledge of the property. This ten acres of property will eventually be taken over by the town. The town will seek federal funding to clean up the site. Right now, there is \$350,000 for three phases of cleanup. Currently on phase 2.

They walked around the parameter of the property, talked with businesses, residents, and handed out informational material. Abutters have to give permission to go on their property during testing. Anybody with a private well within 500 ft. of the Attleboro Dye Works building can have it tested and will get the results. The project will take three years.

The town has to decide what to do with the property. Public hearings are scheduled for Tuesday, July 24, from 7 to 8 p. m. at the Seekonk Memorial Baptist Church, 340 Central Avenue, and Wednesday, September 26, at Town Hall. There will be people to answer any questions and listen to suggestions.

Ms. Hines reminded residents of the special election on Monday, July 16, 2018, for approval of funding for Aitken School doors and windows. Polls are open from 7 a.m. to 8 p.m.

She noted the next town meeting is on Monday, November 12, 2018 at the high school.
