

**BOARD OF SELECTMEN**  
**MAY 12, 2021**  
**REGULAR SESSION**

The meeting was held at the Seekonk Senior Center, 540 Arcade Avenue.

Chairman Sullivan opened the meeting at 6 p.m. followed by the Pledge of Allegiance and moment of silence.

He announced that, per Gov. Baker's Order suspending certain provisions of the Open Meeting Law, M.G.L. Chapter 30A, Section 20, it is necessary to limit the number of attendees allowed to physically access the Board of Selectmen meeting to 25. Masks are required for those in attendance.

The public could have submitted comments and questions to the Board in advance of the meeting by completing the Google Form by Tuesday, May 11, 2021, at 4:30 p.m. The meeting will be broadcast live on TV9 and streamed live on TV9's Facebook.

Any person recording must notify the Chairman at the beginning of the meeting.

**BOARD AND COMMITTEE OPENINGS**

Mr. Andrade announced that volunteers are needed on the Board of Health (1 Board of Selectmen appointment), Capital Improvement Committee (2 BOS), Commission on Disability (5-13 BOS), Economic Development Committee (5 BOS), Energy Committee (1 BOS), Historical Commission (3 BOS), Parks & Recreation (1 BOS), Recycling Committee (3 BOS), South End Fire Station Building Committee (1 Moderator), Veterans' Council (2 BOS), Zoning Board of Appeals (2 Alternates).

Mr. John Alves, 25 River Street, repeated comments he made at previous meetings that the Town of Norton lumped three items together into one debt exclusion and the Town agreed with it. He felt that was commendable.

**Consider Increasing the Number of Members on the Veterans' Council from 5 to 7**

Chairman Sullivan explained there are three applicants looking to join the Veterans' Council. The State allows up to 15 people.

Chief Rave commended the firefighters for lifesaving actions that happened on Saturday, March 5, 2021 regarding a rollover on Taunton Avenue at Lincoln Street. Firefighters used the Jaws of Life to extricate a female from the vehicle.

**Discussion of the Process for the Remaining Open Cannabis Licenses**

Chairman Sullivan stated that the interview process for manufacturing and cultivation is over. It is time to go to the transportation, research and laboratory licenses in town. An applicant is interested in one or all three and one has an interest in transportation. There are no rules on how to handle applications. He felt it is in the town's best interest to have a definitive time line to hear applicants. Board members agreed 90 days is an appropriate time. On September 1, the Board will review and decide whether to go with a plan to bring applicants in two weeks after submission or leave it open a little longer.

Mr. Petronio said he would like input from public safety and the Board of Health.

Mr. Cadime added the Building Inspector as well.

**Consider the Appointment of a Board of Selectmen Member to the Bristol County Advisory Board**

Chairman Sullivan motioned, seconded by Mr. Petronio, and it was unanimously

**General Discussion of Spring Town Meeting**

Chairman Sullivan thanked those who attended. The attendance was amazing. The meeting was postponed until Saturday, May 22, 2021, at 10 a.m. at the football field. That would accommodate 400 to 500 people spaced out.

Mr. Petronio noted that the Seekonk Showcase might be a possibility in the future. He is waiting for a packet of information which he will forward to the Town Administrator. It's important to make sure the town meeting is done legally. He inquired about a tent.

Mr. Cadime said tents will be set up to keep people out of the sun and also for EMS purposes. The information will be provided to residents prior to the meeting. There should be more information by Wednesday of next week.

Chairman Sullivan said the library group and the group for the high school turf will have visuals that people can view as they are signing in.

Mr. Zorra wanted information on check-in.

Mr. Cadime said there will be limited staff at check-in after the meeting starts. The process begins an hour before the town meeting starts.

Mr. Petronio emphasized that articles can be revisited.
