

Saturday, March 15th ANNUAL RABIES CLINIC

The Rabies clinic is open to Seekonk and non-resident animal owners of dogs, cats, and ferrets.

For MA and RI animal owners, in order to be issued a MA three-year Rabies certificate you must bring your previous rabies certificate from your veterinarian or clinic.

Dr. Truesdale from Central Ave Veterinary Hospital will be administering the vaccinations.

Mark your calendar for May 12th, review the warrant, and get involved. Let's come together to make Seekonk an even better place to live, work, and grow.






SOARING ENERGY BILLS IN MASSACHUSETTS: RELIEF EFFORTS UNDERWAY

Massachusetts residents have been hit with unexpectedly high energy bills this winter, prompting Gov. Maura Healey to demand immediate action. In a letter to the Department of Public Utilities (DPU), Healey highlighted concerns over steep natural gas rate increases and urged regulators to provide urgent relief. She noted the financial strain on residents and emphasized the importance of protecting customers from service shut-offs during the winter months.

Lawmakers are also stepping in. Led by Sen. Jacob Oliveira, 80 legislators sent a letter to the DPU, calling for a review of rate hikes and increased accountability for Eversource, which has been at the center of many complaints. Lawmakers cited a case where an Eversource customer's January bill reached nearly \$450, with nearly \$300 attributed to supply costs. Customers of National Grid are also facing rate increases of up to 27%.

In response, the DPU said it is reviewing both Healey's and lawmakers' letters and is working with gas companies to explore options for immediate rate relief. The agency has also been focused on broader energy affordability efforts, which include tiered discounts and other programs to help low- and moderate-income households manage energy costs. Eversource has defended the rate increases, pointing to colder



temperatures and increased energy usage. The utility explained that even if customers do not change their thermostat settings, more energy is needed to maintain indoor temperatures when it's colder outside. January 2025 was reportedly 15% colder than December 2024 and 10% colder than January 2024. However, the company assured customers that it is committed to making energy more affordable and has scheduled webinars to explain bills and available assistance programs.

Gov. Healey also called on utilities to do a better job promoting cost-saving programs like Mass Save, which provides incentives for energy efficiency improvements and heat pump conversions. She stressed the need for more transparency and predictability in future rate changes to prevent customers from being blindsided by sudden price hikes.

With winter far from over, all eyes are now on the DPU and utility companies to take meaningful action. Residents are hopeful that relief measures will be implemented soon to ease the burden of rising energy bills and stabilize future costs.





SOCIAL MEDIA VS. CIVIL DISCOURSE: FINDING A BETTER WAY TO ENGAGE

One of the biggest challenges facing local governments today isn't funding, infrastructure, or staffing—more than any budgetary challenge, civility has become one of the greatest obstacles. The way we engage with one another, especially when we disagree, directly impacts how effective our community can be in solving problems. In recent years, social media has changed the way we communicate, making it easier than ever to share opinions, but it has also amplified negativity, turning discussions combative or even personal.

One of the greatest strengths of Seekonk is its sense of community. We are neighbors, colleagues, and friends, all invested in making this town the best it can be. That means holding passionate discussions, raising concerns, and advocating for what we believe in, while still treating each other with respect. The way we engage today will shape the kind of community we have tomorrow. If we want a Seekonk built on collaboration, progress, and mutual respect, then it starts with how we speak, listen, and work together.

REP. HOWITT SECURES \$10,000 FOR SEEKONK PUBLIC LIBRARY'S TECHNOLOGY UPGRADE

State Representative Steven Howitt has once again delivered for Seekonk, securing a \$10,000 earmark in the state budget to help the Seekonk Public Library replace outdated computer equipment. This funding will provide much-needed upgrades to ensure residents have access to modern, reliable technology.

Earmarks are specific allocations in the state budget that direct funding to particular projects or initiatives, ensuring that critical local needs are met. These funds allow municipalities to make improvements without solely relying on local budgets or taxpayer increases.



Rep. Howitt has a strong record of advocating for Seekonk's needs at the state level, consistently securing earmarks that fund essential community projects. Past successes include funding for the public safety traffic signal, the senior center elevator, and the removal of the Maple Avenue Dam.

With this latest funding, the Seekonk Public Library will be able to provide better digital access and learning opportunities for the community, reinforcing its role as a vital hub for education and technology.

ACCESS FOR ALL: THE VITAL WORK OF SEEKONK'S COMMISSION ON DISABILITY

Municipal Commissions on Disability (CODs) play a crucial role in advocating for accessibility and inclusion within their communities. CODs advise municipal governments on the needs of people with disabilities, ensuring that local programs, services, and facilities remain accessible to all. By providing guidance on compliance with federal and state disability laws, CODs help shape policies that create a more inclusive environment.

Seekonk's Commission on Disability works to amplify the voices of residents with disabilities and address accessibility concerns across town affairs. The commission assists with the town's ADA Self-Evaluation and Transition Plan, reviews development projects for accessibility considerations, and collaborates with municipal departments to improve compliance with disability regulations. Additionally, CODs serve as a vital link between the town, advocates, and state agencies such as the Massachusetts Office on Disability (MOD) to stay updated on evolving laws and best practices.


