## Get Involved: Seekonk's Annual Town Meeting – May 12, 2025

Town Meeting is one of Seekonk's most important civic events, where residents gather to make decisions about the town's budget, projects, and policies. It's a direct way for you to have a voice in the future of your community. The next Town Meeting will be held on **Monday, May 12th at 7:00 PM at Seekonk High School**. This is your opportunity to engage in discussions, vote on key issues, and shape the direction of our town.

Anyone who lives in Seekonk and is registered to vote can attend Town Meeting. It's open to all, and we encourage everyone to come, even if you don't plan to speak. You can learn about the articles being discussed, and your presence shows support for the decisions that impact our daily lives. For detailed information on the agenda, including the 21 articles that will be discussed, visit the Town of Seekonk website ahead of the meeting.

If you're attending Town Meeting for the first time, here are a few tips to help you navigate the process. **Review the warrant in advance** so you know what's being discussed and prepared to ask questions. **Arrive early** to grab a good seat, as meetings can sometimes run long. **Stay respectful during debates**—different opinions are part of the process. Bring water and snacks as discussions can stretch late into the evening, and don't be shy about asking questions if you need clarification.

Town Meeting is your chance to make a difference in Seekonk's future. Whether you're voting on the budget, supporting important projects, or engaging in lively debate, your participation matters. We look forward to seeing you on **May 12th at 7:00 PM** at Seekonk High School!





## SPRING PROGRESS REPORT: BUDGET, TOWN MEETING, AND COMMUNITY EVENTS

As spring turns to summer, our town is buzzing with activity, and I'm pleased to share a few updates on the work happening across departments.

### Fiscal Year 2026 Budget

We are nearing the finish line for the Fiscal Year 2026 budget. Throughout April, we worked closely with the Select Board and Finance Committee to review department requests and capital priorities. Thank you to everyone who participated in the budget and public hearing process. The budget will be presented for a vote at Town Meeting later this month, and we encourage all residents to attend and take part in these important decisions.

### Annual Town Meeting

Our Annual Town Meeting will take place on Monday, May 12th at 7:00 PM at Seekonk High School. In addition to the operating budget, the warrant includes several key articles:

## DPW GEARS UP FOR \$2 MILLION IN ROAD IMPROVEMENTS THIS SUMMER

The Seekonk Department of Public Works is preparing to launch an ambitious slate of road improvement projects this summer, with over **\$2 million** in planned investments. The work will focus on resurfacing, drainage improvements, and roadway upgrades across several neighborhoods, aiming to enhance safety, extend road life, and improve overall driving conditions for residents and visitors alike.

These improvements are part of the Town's yearly commitment to maintaining and investing in its infrastructure. Residents may experience temporary detours or delays in work zones, but the DPW will make every effort to minimize disruption and provide advance notice for impacted areas. ### Accessory Dwelling Units

ADUs are small, self-contained living spaces located on the same lot as a single-family home. Often called in-law apartments, garage apartments, or backyard cottages, ADUs offer flexible housing options for families, seniors, and renters. In Massachusetts, recent changes to state law, allow homeowners to create ADUs by allowing them **"as of right"** in single-family zones.



## EMBRACING THE FUTURE OF HOUSING: ADU GUIDELINES FOR MUNICIPALITIES

On March 19, the Executive Office of Housing and Livable Communities (EOHLC) released its much-anticipated model zoning and guidance document to help municipalities implement the recently established **Accessory Dwelling Unit (ADU) regulations**. These regulations, which became effective on January 31, mark a crucial shift in how Massachusetts is addressing its growing housing needs. By allowing ADUs as-of-right in all single-family zones, the state is making a bold move toward increasing affordable housing options while maintaining the character of its communities.

These new guidelines provide municipalities with the tools they need to adjust local zoning laws in a way that's both efficient and in line with the state's housing goals. The checklist and annotated zoning code offer clear, practical steps for planners to follow, ensuring smooth implementation across diverse communities.

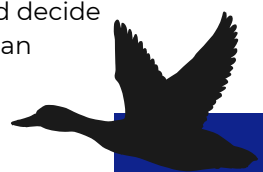

## COMMUNITY PRESERVATION ACT: A VITAL INVESTMENT IN SEEKONK'S FUTURE

As we approach our Annual Town Meeting, where we will vote to appropriate funds from the **Community Preservation Act (CPA)**, it's important to pause and reflect on just how critical this program is for Seekonk. For many, the CPA may seem like one of those behind-the-scenes initiatives, a line item that doesn't always grab the spotlight, but it's an essential part of how our community grows and thrives.

Enacted in Massachusetts in 2000, the **Community Preservation Act** allows municipalities to raise funds through a small surcharge on local property taxes, which is then matched by the state. This fund is designated for the **preservation of open space, historic resources, affordable housing, and recreational facilities**—key pillars that sustain the character and quality of life in any town. Seekonk, which adopted the CPA in 2002, has reaped the benefits of this program for over two decades. In that time, the funds have supported numerous initiatives that directly enhance our community.

Each year, the town sets aside a portion of the CPA funds for projects that align with the goals of the program. This process culminates in the Annual Town Meeting, where voters decide on the specific allocation of the funds. The upcoming meeting will be no different, as the town seeks approval to continue funding these vital efforts.

In Seekonk, CPA money has already helped to preserve open spaces that enhance the natural beauty of our town. Projects like the conservation of key parcels of land ensure that future generations will have access to the scenic outdoor spaces we cherish today. The town has also invested in historic preservation, helping to maintain the unique architecture and landmarks that give Seekonk its distinct character. These efforts not only preserve our heritage but also contribute to the town's overall aesthetic and cultural identity.



One of the most significant aspects of the CPA is the state's matching funds. In Seekonk, the state provides a substantial match, increasing the impact of every dollar raised through the local surcharge. This means that the town's investment in these areas is significantly amplified, stretching our tax dollars further and enabling us to take on larger, more ambitious projects. Without this state funding, many of the projects we've been able to support would not have been possible.

As we head into the Annual Town Meeting, it's important to remember that the decisions we make about the CPA fund are investments in our future. The money we approve today will help build a more vibrant, sustainable, and inclusive Seekonk for years to come. From preserving our natural environment to supporting affordable housing, from enhancing our historic sites to providing recreational opportunities for future generations, the CPA touches every corner of life in our town.

The upcoming vote on the appropriation of CPA funds is more than just a routine procedure—it's an opportunity for us to reaffirm our commitment to building a town that values preservation, accessibility, and community. The projects funded by the CPA are investments in the things that make Seekonk a special place to live, work, and raise a family.







## GOVERNOR HEALEY UNVEILS BOLD PLAN TO LOWER ENERGY BILLS FOR MASSACHUSETTS RESIDENTS

On March 10, Governor Maura Healey took a significant step toward easing the financial burden of energy bills for Massachusetts residents with the launch of her Energy Affordability Agenda. This initiative is not just a short-term fix; it's a full-fledged effort to tackle energy costs head-on, promising to save \$220 million in April alone and a staggering \$5.8 billion over the next five years. The plan's focus is simple but impactful: reduce costs, eliminate price volatility, and make energy more affordable for all residents. And with inflation and rising prices still looming large, this couldn't have come at a better time.

The most immediate relief comes through a \$50 credit on the bills of residential customers served by Eversource, National Grid, and Unitil. This is expected to bring a much-needed breath of fresh air to households struggling to stay afloat as energy costs surge. But the Healey administration isn't stopping there. Over the next year, the Department of Public Utilities (DPU) will work to establish a first-of-its-kind moderate-income discount rate, alongside expanding existing tiered discounts for

lower-income families. For heat pump users, the savings could reach up to \$1,000 during the winter months—a real game-changer for many.



But what really sets this plan apart is its long-term vision. It's not just about quick fixes, it's about fundamentally rethinking how Massachusetts handles energy pricing. The administration is reviewing every charge tied to electric grid infrastructure, looking for ways to finance improvements without slamming customers with steep bills. Moreover, the state is committed to eliminating unnecessary programs that no longer serve their purpose, which will reduce the costs passed on to consumers.

Another key aspect of the agenda is its commitment to innovation. By exploring fixed-price contracts for clean energy and new rate designs, the administration hopes to lock in more predictable prices for the future, helping residents avoid the kind of sticker shock that often comes with fluctuating energy costs. The administration is also rolling out an outreach and engagement strategy to ensure that all eligible residents can access discount rates and energy assistance. After all, what good is a savings plan if people don't know how to access it?

Governor Healey's Energy Affordability Agenda isn't just a set of policies—it's a lifeline for Massachusetts residents. By focusing on both immediate savings and long-term solutions, this plan aims to make energy costs more manageable, while also ensuring that the state's energy infrastructure can keep up with the demands of the future. And as energy bills continue to climb, the Healey administration's commitment to both affordability and innovation could very well be the blueprint other states need to follow. It's an exciting step forward, and one that promises to make a tangible difference in the lives of everyday residents.

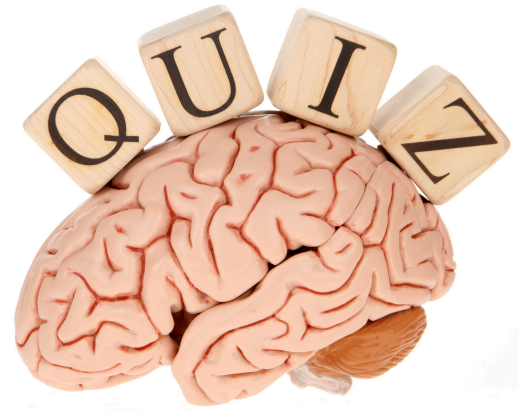
